The 4th edition of the EU-PAIR 2025 International Conference is dedicated to exploring innovative approaches, challenges, and best practices in fostering digital age among learners, educators, and policymakers. The EU-PAIR Conference 2025 theme is EU Digital Strategy: Governance, Innovation and Business

In the European Union, digital strategy is crucial in fostering an inclusive, responsible, and secure digital society. As digital technologies increasingly shape education, work, and civic participation, EU citizens must develop digital literacy, critical thinking, and online responsibility. The digital strategy ensures individuals and businesses can engage safely and ethically in the digital world, protecting their rights while combating misinformation, cyber threats, and digital exclusion. Through initiatives like the **Digital Education Action Plan** and **European Digital Strategy**, the EU promotes digital inclusion, empowering citizens with the skills needed for an interconnected, democratic, and innovative future.

Conference Focus: The conference will focus on exploring innovative strategies for fostering digital skills among diverse populations, including marginalized communities, online privacy, data protection, responsible digital behavior, cyberbullying, misinformation, and the ethical use of AI in education and business, understanding digital rights in the EU and global governance frameworks, promoting responsible digital citizenship through legal and policy initiatives, E-governance, digital activism, and civic participation in the EU.

The interdisciplinarity of the EU administrative science field permits to have a broader list of subjects for debating from all areas of research. Participants are encouraged to delve into topics including but not limited to: digital skills, AI and cybersecurity, digital ethics, digital behavior, digital rights and responsibilities, digital activism, civic participation, youth engagement, and digital business.

The papers (maximum 2 papers/person) presented during the EU-PAIR 2025 will be double peer-reviewed for originality, clarity, significance, and scientific contributions. The accepted papers will be sent to be included in the Scientific Proceeding of the Conference. **The previous EU-PAIR proceedings were indexed into ProQuest under Clarivate** - **E-Book Series, CEEOL, and Google Scholar databases.**
